TAKING ACTION

We continue to invest in a modern vehicle and trailer fleet which include the use of high capacity long semi-trailers (LST) which gives us greater carrying capacity on each load.

**PALLET
TRACK**

Our association with our pallet network Pallet-Track helps us to reduce our dedicated A-2-B mileage by consigning smaller volume loads onto the network.

We outwardly engage with strategic partners across the UK to optimise our general haulage routes which results in better trailer fill and less empty (return) running.

Our extensive 100,000 sq. ft of warehousing is not heated and works on passive lighting. Furthermore, we have industrial cardboard and plastic compactors to reduce waste size which is then fully recycled. We also recycle all wood waste on site.

Our electricity supply is backed by a Guarantee of Origin. This guarantees that 100% of the energy we use is matched by renewable sources and backed by a Renewable Energy Guarantee of Origin (REGO).

All our vehicles are fully tracked to ensure best route optimisation, all are Euro 6 emissions (or better) and are DSV (camera compliant).

We have commenced a full swap out program which will see all 12 of our diesel-powered fork-lift trucks exchanged for full electric versions. We anticipate this major investment to be completed in 18-months. (from April 2025).

Our onsite vehicle maintenance workshop responsibly sources recycled component parts, materials and oils where possible to maintain our fleet. We also responsibly discard used materials correctly through separation.

We have merged and created flexible shift patterns to enable our driver and fork-lift staff to car share from local conurbations.
